



We are honored to gather the New Mexico social sector at the Pueblo of Isleta. We express our deep gratitude to Governor Zuni and the Tribal Members of the Pueblo of Isleta for hosting Groundworks New Mexico's Annual Social Sector Conference.

The Pueblo of Isleta is one of the larger 19 Pueblos within New Mexico and was established in the 1300s. Isleta Pueblo covers an area of more than 329 square miles, surrounded by the Manzano Mountains to the east and to the desert mesa lands of the Rio Puerco on the west. The name Isleta comes from the Spanish language which means "Little Island."



We know the stat, according to the 2023 Annie E. Casey Foundation's Kids Count Databook, New Mexico ranks last nationally for childhood well-being. Last year, 24 percent of children were living in poverty and 35 percent of children had parents who lacked secure employment. Despite this, we also know that New Mexico leads the way in creating programs that enhance essential social safety nets and through systemic changes that not only fight poverty, but make family economic stability possible.

This panel, sponsored by the New Mexico Asset Funders Network seeks to dismantle systemic barriers people face when trying to find economic security and strive to find effective, integrated, and sustainable systemic solutions that enable families to move through safety nets into financial security and opportunity. During this panel we will discuss the important distinctions between poverty alleviation and wealth-building as ultimate goals of our work, highlight how direct services and systems change are compliments, and explore how nonprofits, funders, financial institutions, and policy makers can work together to achieve lasting change toward making economic stability possible for all New Mexicans.

The Inflation Reduction Act, Infrastructure, Investment & Jobs Act, Chips & Science Act, and Justice40 initiative bring historic funding levels and opportunities. Many of these federal programs have limited timeframes and are one-time investments. A group of 13 funders came together to commission the Grant Plant to conduct research in key priority areas including: broadband, early child education and development, employment equity, food and agriculture, health equity, homeless services, housing, K-12 education, and water. The research also looked at opportunities for public/private partnership, identify the highest leverage points for building capacity in the sector, and to determine what role philanthropy can play in assisting non-profits and rural, local and tribal governments in receiving federal funding.

The panel following of grantees and funders will discuss recent efforts to support non-profits and tribal governments pursuit of federal funding. The panel will include the Pursuing Federal Funds program, which established pooled funds for non-profits to hire grant-writers, which led to awards of more than \$37M in federal funds. The panel will also include the impact of the Native American Recovery Fund's effort to support collaborative efforts among native led organizations and tribal governments to identify and garner federal funding.

Trust-based philanthropy has been gaining momentum as an approach that alleviates power imbalances toward a more just and equitable nonprofit sector. While it is most associated with unrestricted grants and streamlined applications and reports, it is much greater than the sum of these practices. Fundamentally, trust-based philanthropy flips the script on the compliance-oriented culture of traditional philanthropy so that nonprofits have the agency and opportunity to achieve their goals.

But what does it actually look like to embody trust-based values in our work? What is the process of building trust and mutual accountability in a sector that has perpetuated harm? And how can we work together to create a culture of trust across our social sector ecosystem in New Mexico?

Join us for an engaging plenary panel discussion as we explore these questions together, hear from leaders who are operationalizing trust-based values and practices in different ways, and leave you with a renewed sense of understanding of the potential of trust-based philanthropy for our sector.




Lyn Wilson
